Attached are the July Financial reports. I hope to be caught up soon.

July gain of \$552.79 brings the year-to-date loss to \$995.04. The loss is still less than budgeted. Remember to mention at your Zoom meetings that personal contributions are in order. Many members support using the PayPal account, others send it directly to the intergroup. Hopefully, we will be able to have some online activities that will assist in reducing the loss.

The office is now open for making contributions and for literature purchases – but it is still BY APPOINTMENT ONLY during weekday office hours. As Covid 19 issues seem to be subsiding, we are extending access for all transactions, but they will need to be limited to “appointments” only. During normal weekday hours the office staff will continue to answer phone calls, respond to emails and process contributions mailed to the office.
